Any tent structure larger than 499 sqft will revert back to "Commercial Annual" and be invoiced by the square footage. (Good for 180 days)

Nuisance Alarms: The Springfield Twp. Fire Dept. will allow no more than 4 fire alarms in a 30 day period or a max of 6 alarms in a 90 day period. The business or agency shall pay a nuisance fee of \$500.00 per alarm .

Repetitive Violations: The Springfield Twp. Fire Dept. will allow no more than 3 repetitive violations in a 30 day period or a max of 6 repetitive violations in a 90 day period. The business or agency shall pay a noncompliance fee of \$500.00 per repetitive violation.

PERMITS:

Springfield Township Inspection Bureau has the authority to waive any and or all fees:

Fireworks or Pyrotechnical event (Per event/Day):	\$300.00
Fireworks Sales (Novelty items) Permit must be renewed Annually	\$25.00

Firewatch - per hour per employee	\$50.00
-----------------------------------	----------------

(Firewatch = the amount of personnel required for firewatch will be decided by the authority having jurisdiction.)

Station Tours: **Free**

These can be scheduled by calling the FPO: Contact Josh Bradley for a appointment.

PR Events: **Free**

These are normally limited to **2hrs** in length and depend highly on staff availability. Can be scheduled by calling the FPO: Josh Bradley
 (Firepup is an option depending on staffing once again)

Festivals: (Excludes Fireworks - They are invoiced separately)	\$250.00
A flat fee of \$250 to a festival committee/group/organization for up to 20 consession/sales trailers will be charged.	(\$10.00 each add'l over 20)

An additional \$10 per trailer will be added over 20 units. (Who gets inspected) Any enclosed sales trailer or tent set up for using cooking oils or burners including but not limited to deep fryers, gas grills, griddles, and electric skillets, microwaves, etc. All tents and trailers are subject to inspection for hazards and egress etc. (The inpection will be good for the duration of the festival only)

Any booth with electrical connection shall be inspected.

PAYMENT MUST BE MADE PRIOR TO THE FESTIVAL FESTIVITIES OPENING.
