**Resolution #212-19:** Trustee Currens moved to adopt a resolution to approve the reimbursement to Township Trustee Paul Gleisinger in 2020 for each of his out-of-pocket premiums attributable from his employer's health care plan because of his election not to participate in the township's health care plan, seconded by Trustee Orewiler, and upon a roll call vote all members voted as followed:

• Mr. Robert W. Currens AYE

• Mr. Brad E. Orewiler AYE

• Mr. Paul L. Gleisinger ABSTAINED

Trustee Currens left the meeting at 6:54 pm.

Motion #213-19: Trustee Gleisinger moved to take the money that is saved from the premiums towards each full-time employee's HSA account and use the difference out of the general fund. Each employee will get \$4,000 for a family and \$2,000 for an individual, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE."

The Board discussed what funds to take all HSA contributions out of.

**Motion #214-19**: Trustee Gleisinger made a motion stating that the general fund will pay \$500 towards every single employee's HSA account and \$1,500 out of the fund they work out of with a total contribution of \$2,000. The general fund will pay \$1,500 towards every family employee's HSA account and \$2,500 out of fund they work out of with a total contribution of \$4,000, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE."

Motion #215-19: Trustee Orewiler moved to accept the resignations of part-time firefighters Kevin Phillips effective December 10, 2019, Captain Ron Eyerly effective 12/31/19, Richard Kovacs and Richard Bittner effective December 16, 2019, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

The house at 2890 Alta West has been demolished.

Trustee Orewiler will have an HSA resolution at the next meeting.

The Board signed the November Management reports.

F.O. Kochheiser presented the Board with the Temporary Appropriations for 2020.

**Motion #216-19**: Trustee Orewiler made a motion to accept the 2020 Temporary Appropriations as prepared by the Fiscal Officer to make it possible to pay the bills for the year 2020, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

Resolution #217-19: Trustee Orewiler moved to adopt a resolution that Springfield Township Trustees makes a Section 125 Premium Conversion Plan benefit available to its employees and pays a portion of those premiums as set forth in the attached Plan. The Corporation wishes to adopt such Plan as it complies with the Internal Revenue Code to enable its employees to elect to pay their share of the group insurance premiums on a pre-tax salary reduction basis. The plan, as presented to this meeting, is hereby approved and adopted and the proper officers of the Corporation are hereby authorized and directed to execute and deliver to the administrator of the Plan one or more counterparts of the Plan, seconded by Trustee Gleisinger, and upon a roll call vote all members voted as followed:
