John Chime, Chaplin from Clear Minds Coaching & Counseling, talked to the Board about his counseling services and how he can help our firefighters specifically with the stresses of the job.

Motion #157-20: Trustee Rose made a motion to give a 30-day cancellation notice to our current Employee Assistance Program with New Directions, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE".

Motion #158-20: Trustee Rose made a motion to approve a Delinquent Debt Agreement between the Ohio Attorney General's office and Springfield Township Fire Department to take care of our delinquent EMS Billing and Fire Prevention bills, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE".

The levy renewals were discussed. Chief Carey has been fielding a lot of phone calls with residents asking why there are two different renewals. He has answered their questions and directed them to our levy website. Don Daugherty expressed his concerns with the current renewals verbiage and encouraged the Board to look into replacing those renewals.

The Board discussed the Cares Act money that the township has received. The Township received another check for \$156,611.34 totaling \$183,657.00 in all. There was discussion on protocol and the process that the department needs to follow when spending the Cares Act money. Some of the possible items to purchase are as followed:

- Gear washer
- Power lift cot
- Computer upgrades
- Motionless hand soap and towel dispensers
- Recliners to replace the current cloth recliners
- Support 22 replacement
- Upgraded phone system
- Electronic signs for each station
- Uniforms
- Flooring for Township Meeting Hall
- Smoke detectors

The Board approved Chief Carey a blanket approval to spend the Cares Act money as he sees fit.

There will be a special meeting on November 9, 2020 at 6:00pm to interview candidates for the Assistant Chief position.
