Chief is trying to get COVID tests to be able to test employees twice a week. He is working on costs and how to get them and will update the Board as soon as he gets the information.

The Stewart signs for both stations should be in this week. The permits are in and the signs will be scheduled for installation as soon as possible weather permitting.

The fire department has been contacted about getting the COVID vaccines. They need a count of how many employees will be getting one. A waiver will need to be signed if an employee opts out.
