Public was given a phone number to call in to have access and participate in the meeting remotely as well as an online meeting ID to join a web conference.

Trustee Rose had a question regarding the back hoe purchase. She wanted to know when it was approved and if we traded the old one. It was approved in December and we sold the old one to Sandusky Township.

The green house signs were discussed. The fire department was going to push the signs so that everyone has one but the project is on hold until after the COVID-19 pandemic. It was discussed creating a resolution mandating every house to have one. The Board agreed to still give each residence the first sign and then if they need another one it would be \$8.

Trustee Rose asked what the magic card maker is? It's what the fire department uses to make the ID's for every firefighter.

Chief Carey updated the Board on matters dealing with COVID-19. They have been working on a decon area at Avita Hospital. Processes have changed when responding on calls. Lots of safety measures have been put in place to protect the fireman.

Ellen Meredith updated the Board with some run statistics regarding possible PPE patients. Daily training is still taking place. Testing results are coming in quicker. Inspector Bradley is working as the EMS safety officer. He is going on all squad runs to make sure things are being done correctly. All testing tent locations have to be inspected.

Trustee Rose has been in contact with Chief Carey on daily briefings so that the Board is kept informed.

The Board discussed the updated temporary Sick Leave Policy. Chief is requesting an increase in hours to 96 hours of pay for all full-time firefighters and the salary employees will stay at 80 hours.

Motion #50-20: Trustee Orewiler made a motion to approve the updated Temporary Emergency Paid Sick Leave Policy (COVID-19), seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE".

Motion #51-20: Trustee Gleisinger moved to allow the Fire Chief to grant paid administrative leave to his staff as he deems necessary and to flex staffing to help pay for this benefit. This will be a temporary policy from April 6, 2020 expiring December 31, 2020. This policy is subject to amendment or rescission by the Springfield Township Trustees at any time, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE".

Motion #52-20: Trustee Orewiler made a motion to approve the Temporary Expanded Family Medical Leave Act (FFCRA) (COVID-19), Policy, seconded by Trustee Rose and upon a roll call vote all members voted "AYE".

Trustee Gleisinger updated the Board on the road department. The backhoe is supposed to be in this week. They are going to try and put up the welcome signs this week. Starting today, they are returning to work with temperature checks every day at the beginning of shift and at the end of shift. The recycle bins are being overwhelmed with trash.

Motion #54-20: Trustee Gleisinger made a motion to issue that all nonessential employees be allowed to work from home and on call as needed with their regular pay through May 1st. This will apply to the following employees: William Scott and Kirstin Gray, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE". Robyn Gast will still be coming into work until Chief Carey states otherwise.

Motion #55-20: Trustee Orewiler moved to renew the contract with Careworks for \$4,440 to manage the townships BWC claims for 2021, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE".

FO Kochheiser presented the Board with a 90-day notice of cancellation with AMB.

Motion #56-20: Trustee Rose made a motion to sign and submit a 90-day Notice of Cancellation to AMB effective April 7, 2020 seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE".

FO Kochheiser presented the Board with the township's Medicount contract to review for the next meeting. She will be sending the contract to the RCPO for their review as well.

Regarding the St#2 cell tower, Trustee Orewiler will send the updated contract with changes by Verizon to the Prosecutor's office for review.

FO Kochheiser presented the Board with 3 purchase orders for them to review and sign.
