Public was given a phone number to call in to have access and participate in the meeting remotely as well as an online meeting ID to join a web conference.

Trustee Orewiler had a question for Chief Carey on the cost of new employment testing and what all is included in the testing.

Chief updated the Board on his negotiations with Medicount regarding the contract. He was able to get the rate dropped and locked in for 4-years. It will be 6% for the first year and 6.5% for year 2, 3, and 4. Chief Carey will have the updated contract at the next meeting.

Trustee Orewiler has received more complaints on the 2116 Frey Road property. There are atleast 20 junk cars and 3 campers on the property. The Zoning Inspector has sent letters to the property owner regarding the zoning violations. Resolution 87-19 was adopted on May 20, 2019 to remove the junk vehicles and trash on the property within 14 days of the receipt of this Resolution. The property was cleaned up after that resolution but it has been filled back up with the junk vehicles.

Trustee Orewiler updated the Board on the Verizon cell tower. The contract has been reviewed by the Prosecutor's Office.

Motion #69-20: Trustee Gleisinger moved to approve the Right of Entry agreement between Verizon and Springfield Township regarding the cell tower behind Station #22, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE".

Trustee Gleisinger updated the Board on the road department. They have been busy with ditching, tiling and mowing. They fixed a washout on Rudy Road and installed a new driveway approach on a Cookton-Grange property.

The Road Department drove around the township and put together a list of trees that will need to be removed. They got the following quotes to remove twelve trees:

- Oberlanders Tree and Landscape: \$1,600
- Mid-Ohio Tree Service: \$3,500

Motion #70-20: Trustee Rose moved to accept the quote from Oberlanders Tree and Landscape to cut down twelve trees throughout the township for \$1,600, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE".

FO Kochheiser has received the check from Sandusky Township for the townships old backhoe.

Craig Hunt had a question if a property with a couch out in the yard is in our township. He was informed that it was in Troy Township.

Captain Mullins updated the Board on all the problems in the past 15 years that the township has had with the property owner of 2116 Frey Road.

Captain Mullins also suggested putting up more of the Welcome Signs on State Route 30, State Route 309, and State Route 181. It could help with identifiers for people calling into 911. The Fire Department has had problems finding the locations on some calls and adding more signs could help. The Board is in agreement and talked about making them bigger due to the speeds on those roads. Trustee Rose asked Chief Carey if he could make his top 10 roads that could use a sign.

It was discussed how a lot of residents don't even know that Springfield Township Fire Department is the fire department for the City of Ontario.
