Public was given a phone number to call in to have access and participate in the meeting remotely as well as an online meeting ID to join a web conference.

Station #1 is having problems with its alarm system. Captain Mullins is getting quotes to figure out what is going on and to get it fixed.

The storm that came through last week did some damage to the Station #2 roof. Chief is looking at turning it into our insurance to get that section fixed. He is still getting quotes to have the entire roof replaced.

Chief Carey presented the Board with a proposal for Lexipol. The Ohio Plan will pay 50% of it the 1st year, 30% the 2nd year, and 20% the 3rd year. Chief is hoping to have an updated contract with the Ohio Plans discounts at the next meeting

Chief Carey updated the Board on the AMB contract. The Board discussed some negotiating points to possibly lower the fees that are involved with canceling our contract.

Chief Carey updated the Board on the upcoming Ontario BOOM Festival. He presented a map of what the festival will look like.

Chief Carey updated the Board on the protest that took place last week. The fire department worked with Ontario PD and everything went smoothly.

Chief Carey presented the Board with a RFP proposal regarding fire/EMS coverage in Sandusky Township. The Board had a lot of questions that Chief was able to answer.

Trustee Rose addresses the fact that our Employee Assistance Program does not address mental health issues for first responders. She would like us to look into other programs.
