Public was given a phone number to call in to have access and participate in the meeting remotely as well as an online meeting ID to join a web conference.

The Board discussed the RFP proposal regarding fire/EMS coverage in Sandusky Township. The proposal includes a 3-year contract with an opt out option.

Chief Carey informed the Board that there may be an increase in mutual aid calls with Crestline Fire as they are down firefighters at the moment.

Motion #115-20: Trustee Orewiler made a motion to respond to the request for a proposal solicited by Sandusky Township, Richland County, Ohio for providing fire/EMS coverage, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE".

Trustee Orewiler updated the Board on the roof at St#2. He is waiting on some more quotes and should have them all at the next meeting.

Trustee Orewiler received a call from an Alta West Road property owner regarding a complaint on a neighboring property not being mowed. If it's more than 3 acres, it is considered agriculture and doesn't need to be mowed.

Trustee Orewiler received a call from an Alta West Road property owner with a complaint about the road itself with the tar seeping through and the excess sand and gravel. Trustee Gleisinger will contact Small's Asphalt & Paving to come and look at the road to see if anything can be done.

The Board discussed the Lexipol proposal. The Prosecutor's office is reviewing it.

Motion #116-20: Trustee Orewiler moved to go into a 2-year contract with Lexipol costing \$10,777 for the first year to be paid out of the general fund and \$2,693 for the 2nd year to be paid out of the fire department fund. Once approved by the Prosecutors Office, the Board gives Chief Carey permission to sign the contract and send it to Lexipol, seconded by Trustee Rose and upon a roll call vote all members voted "AYE".

Trustee Gleisinger updated the Board on the road department. They have been busy mowing. The diesel pump has been installed. They have delivered the No Engine Brake Signs.

The township cemeteries were discussed. The road department mows all of the cemeteries.

Trustee Gleisinger presented the Board with some information regarding Zoning Amendments and what the Board is required to do.

Trustee Gleisinger received a complaint regarding the property at 1341 Lewis Road. The grass is overgrown. The property owner is in the nursing home. The attorney handling the estate will be sending someone to mow the property.

The Board signed the MT Business Technologies contract. This contract was previously approved & signed with redactions and MT/US Bank requested an original unredacted contract be resigned and also an addendum which replaces the redactions on the previous contract.

The lighting districts were discussed. The township is paying more than what we are bringing in. The tax assessment for the Walcrest lighting district will need to be adjusted up as we are not collecting enough revenue to cover the electric costs of the district. These are due the 1st of September for re-certification. The F.O. is working on them currently.

Public Comment:

Craig Hunt had questions on the Alta West Road problems. He asked if it would help if there were "No Thru Trucks" signs. It's happening to a lot of the recently chip and sealed roads. He also asked about the process for the zoning amendments.

Motion #117-20: There being no further business to come before the Board, Trustee Orewiler made a motion to adjourn, seconded by Trustee Gleisinger motion carried.
