AC Wells updated the Board on the new station signs.

Trustee Orewiler updated the Board on an issue with a funeral at Springmill Cemetery.

Springmill Cemetery has been having some flooding issues. The Road Department will work on fixing it in the spring.

Trustee Orewiler updated the Board on Prince Excavating on Rock Road. It is now gated and doesn't look like any business is going on.

FO Kochheiser did verify with the Prosecutor's Office to see if someone could 2nd a motion if that motion had to do with that person. It is allowed.

Trustee Gleisinger updated the Board on the road department. They have had a few burials. They put in some tile on Gfreer Road and helped Sandusky Township patch some roads.

Trustee Gleisinger asked the Board if they would consider giving a phone to Road Laborer instead of only the Road Foreman. They decided not to at this time and discussed possibly getting them a MARCS radio to use.

The new phone systems should be ready to go live by January 28th.

The transmission on the road department's 350 1-1/2 ton truck has been having some problems. After having it looked at, it will need to be replaced. It will cost approximately \$6,400. The Board approved.

Motion #06-21: Trustee Gleisinger made a motion amending the 2021 Organizational meeting to include an additional .50 an hour beginning the first pay period of 2022 for Road Foreman Charlie Kleilein, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE."

The Board discussed some proposed benefit updates for the Road Department with the changes being on sick leave, bereavement, longevity and vacation.

The Board also discussed how unused vacation time is handled between the road department and fire department.

The Board signed the December Management reports.
