Public was given a phone number to call in to have access and participate in the meeting remotely as well as an online meeting ID to join a web conference.

AC Wells updated the Board on the new signs. They are installed and working. Employees are getting trained on how to use them. Trustee Orewiler asked to have the bushes removed from the north side of the sign at St#2 so oncoming traffic can view the sign easier.

AC Wells presented the Board with the 2020 EMS and Fire reports covering payroll, EMS billing and run volumes/run types. The Board had some questions regarding call response time with the addition of Sandusky Township.

The Board signed the Clear Minds Coaching & Coaching, LLC Employee Assistance Program agreement, effective January 1, 2021 through December 31, 2021.

The majority of full-time firefighters have had the COVID-19 vaccine.

Trustee Orewiler asked the Board's thoughts on having separate winter and summer hours for the Zoning Inspector. The Board suggested talking to Scottie first to see how he feels about it.

Trustee Gleisinger updated the Board on the road department. The F550 truck is back in service. They replaced a drive pipe on Sherman Road.

The road department trailer is having problems hauling the mini excavator. It weighs more than what the trailer can carry. They received the following quotes for a new trailer:

- \$11,293 from Pine View Trailer Ltd.
- \$19,150 from Wellington Implement

They discussed whether to trade in the old trailer or possibly keep it for the fire department.

Motion #12-21: Trustee Gleisinger made a motion to purchase a new trailer from Pine View Trailer Ltd. in the amount of \$11,293 less \$3,000 trade in for a total of \$8,293 to make transporting the mini excavator street legal, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE."

Trustee Gleisinger updated the Board on the MS4 program.

Erica Thomas, from Richland County Soil and Water, would like to come to our next meeting on February 8<sup>th</sup> to discuss the Black Fork ditch petition.

The Board discussed opening the meetings again to the public. We will remain closed for now until further discussing it with the Health Department on occupancy restrictions.

FO Kochheiser was on location for an EMS call and was very impressed with how the fireman handled it. She also wanted to thank Jon Brown, Josh Bradley and others who helped with the township hall. It looks great!

FO Kochheiser updated the Board on the Walcrest Lighting District. She had to pay \$20.95 towards their bill this month out of the general fund. The Board agreed to transfer \$525 out of the general fund to cover until the tax check comes in April at which time the money would be returned to the general fund. FO Kochheiser is seeking an opinion first from the RCPO to make certain this is permissible and will report back.

FO Kochheiser updated the Board on our Star Plus Investment Account. This account will no longer be endorsed by the State Treasurer's Office and all funds will be automatically be transferred to a regular Star Account. The Township will need to decide whether to leave it in a Star account or to put in a different investment account. We decided to revisit this in a few months.

Motion #13-21: Trustee Orewiler made a motion to forgive the amounts totaling \$20.57 of overpayment in the first pay of 2021, due to a clerical error made when calculating raises for 2021 to:

Trustee Gleisinger seconded the motion and upon a roll call all members voted "AYE".

Motion #14-21: Trustee Orewiler made a motion to forgive \$79.50 of overpayment in the first pay of 2021, due to a clerical error made when calculating raises for 2021 to FF Don Daugherty, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

**Motion #15-21:** Trustee Orewiler made a motion to go into Executive Session at 8:20 p.m. to discuss compensation for employees. Trustee Gleisinger seconded the motion and upon a roll call all members voted "AYE".

Motion #16-21: Trustee Orewiler moved to return to regular session at 10:39 p.m., Trustee Gleisinger seconded and upon a roll call all members voted "AYE".

Chief Carey is being placed on medical leave effective January 25, 2021.

Motion #17-21: Trustee Rose made a motion appoint AC Wells as Interim Chief during Chief Carey's medical leave, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

Motion #18-21: Trustee Orewiler moved to give FF Don Daugherty a \$1.00/hr. raise increasing his pay to \$19.90/hr., seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

Motion #19-21: There being no further business to come before the Board, Trustee Rose made a motion to adjourn, seconded by Trustee Orewiler motion carried.
