Chief has some old EMS items that need to be disposed of. The Board approved. Chief is wanting to make room to move EMS supplies to a more secure location. It is currently in a cabinet in the bay.

Chief Carey updated the Board on L-23. They are close to figuring out what exactly is wrong with it.

Trustee Rose updated the Board on the Health Insurance renewal. Rates came back higher than anticipated. There are no competitive rates at this time. Lori from Assured Partners will continue to negotiate.

Trustee Gleisinger updated the Board on the Road Department. The road striping is done. They have been working with Sandusky Township to patch roads.

Trustee Gleisinger updated the Board on the stimulus project for Alta West. He has been working with Richland County Engineer Adam Gove.

The roof at St#1 has some damage from a rainstorm in August. Trustee Gleisinger has received a quote of \$1,300 before insurance to fix the damage. The problem is the shingle size/color is no longer made so it will be hard to match. According to Ohio's line of sight rule, if the shingles do not match the color/size, the insurer shall replace as much of the item as to result in a reasonably comparable appearance.
