Motion #206-21: Trustee Orewiler made a motion to pay the bills, seconded by Trustee Rose and upon a roll call vote all members voted "AYE."

Public was given a phone number to call in to have access and participate in the meeting remotely.

FO Kochhesier informed the Board that there would be an additional invoice coming at the next meeting from Mid-Ohio Tree Service due to removing one of the trees on Rudy Rd. from the quote and adding a tree on Burnison that was not on the original quote. The difference is \$400.

AC Spellman presented the Board with a quote from Fire Station Furniture to buy 16 wooden lockers and 4 bed frames for St#2 in the amount of \$13,264.72. 2020 COVID funds would be used.

AC Spellman informed the Board that they are also looking at using the remaining 2020 fund for a fire gear drying system for the stations. They are currently getting quotes.

Motion #207-21: Trustee Orewiler made a motion to approve the purchase of 16 wooden lockers and 4 bed frames from Fire Station Furniture in the amount of \$13,264.72 to be paid for out of the Cares Act Fund. Trustee Rose seconded the motion and upon a roll call all members voted "AYE".

The fire department was awarded a \$10,000 grant from TC Energy. We received a \$5,000 grant last year so will have a total of \$15,000 to use to purchase a UTV to replace the grass truck.

The MARCS grant from the state will be submitted tomorrow.

The Board signed a contract for the AFG Grant that will be used for extrication tools if awarded but wanted to have Chief Carey verify the percentage that Ohio First Responders Grants will get.

Five of the new part-timers will be going on shift as minimum manning beginning next week.

The majority of firefighters have acknowledged the Lexipol policies.

AC Spellman presented the Board with a resignation letter from Brandon Mosher.

Motion #208-21: Trustee Gleisinger made a motion accepting the resignation of Brandon Mosher effective November 1, 2021. Trustee Rose seconded the motion and upon a roll call all members voted "AYE".

Trustee Rose updated the Board on the Health Insurance renewal. There was a 34% increase. There are no competitive bids at the moment but they are still going through claims.

The end of year meeting will be at 9:30 on December 27th and followed by the 2022 organizational meeting.

L-23 is still waiting on parts before it can be fixed.

Trustee Orewiler asked if the American Rescue Fund can be used to purchase a squad. Our attorney is going to be looking into it.

Trustee Orewiler updated the Board on the Prince property on Rock Road. It has sold and the Board will keep their eye on it to make sure that it stays residential.

Trustee Orewiler said that aggregation is going up by 8% next year. Does the Board want to stockpile any aggregates? Trustee Gleisinger will talk with the road department.

Trustee Orewiler wanted to remind the fire department and road department that any purchases need to be made in November. This excludes gas and day to day purchases.

Trustee Gleisinger updated the Board on the Road Department. Leaf pick-up will begin this week and will go through until Thanksgiving. It has been posted on the website.

Trustee Gleisinger is still working with Regional Planning for the ODOT funding grant.

FO Kochheiser updated the Board on the Walcrest Lighting District fund. She is currently waiting on word from the Prosecutors Office to see if we can pay for it out of the general fund for the remaining of the year. It will be able to sustain itself after this year. The Board agreed to go ahead and pay for it out of the general fund.

FO Kochheiser gave the Board information for the Richland County Township Association Holiday Dinner. She needs to know by the next meeting so she can send a check for those attending.

Public Comment:

John Gray asked Trustee Orewiler for clarification on a statement he made in a public forum regarding how he made sure training was kept up-to date within the fire department. In all of his 14 years as training officer John Gray said Trustee Orewiler had never attended. Trustee Orewiler informed him that he meant when they were given the monthly reports to make sure the hours were kept by all employees and that they were up to date.

Don Daugherty doesn't understand why we are waiting for the grant to come through before looking at getting a squad. It can still take up to a year to even get one and cost will continue to go up. Why can't we get it ordered and the price locked in? No money has to be put down when the squad is ordered. It can always be canceled if the funds are not available. Trustee Orewiler is in agreeance with Don and we definitely need to push the issue. The Board wants to hear from Chief to get his thoughts first but does believe it is a good idea.

Craig Hunt would like to thank all of the candidates that are running for township trustee. He wants to wish them all good luck!

Motion #209-21: There being no further business to come before the Board, Trustee Gleisinger made a motion to adjourn, seconded by Trustee Orewiler, motion carried.
