Motion #218-21: Trustee Orewiler made a motion to pay the bills, seconded by Trustee Rose and upon a roll call vote all members voted "AYE."

Motion #219-21: Trustee Gleisinger made a motion to have Matt Harriman replace Howard Harriman on the Springfield Township Zoning Commission when his term ends December 31, 2021, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE."

Motion #220-21: Trustee Gleisinger made a motion to read into the minutes a Proclamation that November 29, 2021 shall be and is proclaimed to be Howard Harriman Day in Springfield Township in recognition and appreciation of his 42 years of public service to the citizens of this township, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE."

Lori Hager, from Assured Partners, presented the Board with options for the township's medical insurance plans for 2022. The options were discussed in depth. The first option is a 10.1% increase for our current coverage plan. Another option is to increase the deductibles from \$3,000/\$6,000 to \$4,000/\$8,000 which will decrease the premiums -1.8% compared to current rates.

Motion #221-21: Trustee Rose made a motion to renew through Assured Partners the Medical Mutual 2022 Health Insurance at the \$4,000/\$8,000 deductible level HSA for a total year savings of 1.8% over last year. The employee HSA account funding to remain the same as last year: \$2,000 individual and \$4,000 for a family plan, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE".

AC Spellman has requested permission to purchase 8-ballistic vests for the trucks in the amount of \$6,440 plus shipping from FDSAS. The Board agreed to wait until next year after review of the 2022 budget.

AC Spellman asked if the Board had a chance to look over the job description for the maintenance technician position. The Board has not had a chance to review it. They were just made aware of a folder in their email that the document had gone into. They discussed whether to hire from within or open up applications.

Don Daugherty updated the Board on L-23. It is still out of service after a new problem.

Trustee Orewiler would like to move forward with the purchase of new medic. AC Spellman is still trying to get ahold of the attorney who is helping us out with our American Rescue Plan funds. They can atleast start looking at models.

Trustee Gleisinger updated the Board on the Road Dept. They have been busy picking up leaves which was completed as of the 24th.

Motion #222-21: Trustee Gleisinger made a motion to accept the 2022 Temporary Appropriations as prepared by the Fiscal Officer to make it possible to pay the bills for the year 2022. Trustee Orewiler seconded the motion upon a roll call vote all members voted "AYE".
