Public was given a phone number to call in to have access and participate in the meeting remotely.

Chief Carey asked for approval to purchase 200ft of 5-inch hose for approximately \$1,500.

Motion #92-21: Trustee Gleisinger made a motion to allow Chief Carey to purchase 200ft of 5-inch hose for approximately \$1,500. Trustee Rose seconded and upon a roll call vote all members voted "AYE".

Chief Carey informed the Board of what all cost are included in Joe Smith's training agreement. The Board discussed how the class was going to be paid. Chief Carey is going to look into past contracts to see how they were handled.

Chief Carey informed the Board of a Cooperative Economic Development Agreement that he believes the township could consider to provide some additional revenue besides the property taxes we currently receive.

Chief Carey updated the Board on the township's DUNS number. The number is now active and will need renewed every year.

Townships were not included in the last round of COVID relief funds, but it is being worked on.

Chief Carey informed the Board of a Safer grant that the township can apply for. The grant would pay 100% of firefighter's salaries up to 6yrs for 5 employees. Chief Carey is wanting to set up a meeting with the Board and a representative with Safer.

A special meeting will be held on May 12th at 6pm to discuss the Safer grant with a Safer representative.

Chief Carey updated the Board on what he learned from a webinar he attended with the Office of Budget Management.

The purchase of another department's ladder truck was discussed and the possibility of selling L-23 to help with the purchase. The purchase of an ambulance was also discussed. Due to the high demand of ambulances, Don Daugherty suggested we go ahead and start the process and we can always back out if we change our mind.

Trustee Orewiler would like the Board to consider giving a raise of to the Zoning Inspector.

Motion #93-21: Trustee Orewiler made a motion to give Zoning Inspector, William Scott, a \$25 a month wage increase effective June 1, 2021. Trustee Gleisinger seconded and upon a roll call vote all members voted "AYE".

The bids for the St#2 roof were discussed. All the bids were reviewed by an architect and they were all acceptable bids.

Motion #94-21: Trustee Orewiler made a motion to reward Alumni Roofing Company, Inc. with the St#2 roof project bid in the amount of \$44,900. Trustee Gleisinger seconded and upon a roll call vote all members voted "AYE".

A resident is wanting to buy the 4.5 acres behind St#1. Trustee Orewiler will inform her that it is not for sale.

Trustee Gleisinger updated the Board on the road department. They have been cutting berm and getting ready for the Chip and Seal Road Resurfacing Project. They have also been busy mowing and salting roads.

The Chip and Seal Road Resurfacing Project bid specs have been advertised and are posted to our website. Bid openings will be May 17th.
