Public was given a phone number to call in to have access and participate in the meeting remotely.

Chief Carey discussed selling some obsolete radios. He presented a list to the Board. Sunny Communications offered us \$1700 and All Season Distribution offered to purchase the radios for \$3,000-\$3,200.

Motion #109-21: Trustee Orewiler made a motion to sell the radios on the list to All Season Distribution for approximately \$3000, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

The Chief wants to purchase promotional items from Alert-All for the 4th of July festival. 500 Frisbees and 500 sunglasses would cost \$1,050.

Motion #110-21: Trustee Rose made a motion to purchase 500 Frisbees and 500 Sunglasses from Alert All for the 4th of July, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE."

The Chief stated that 3 new mounts are needed in the rescue squads for the Life Paks at the amount of \$3,585 from Penn Care as the old ones need replaced.

Motion #111-21: Trustee Orewiler made a motion to purchase 3 new mounts from Penn Care for the Life Paks in the squads at a cost of \$3,585, seconded by Trustee Rose and upon a roll call vote all members voted "AYE."

The Ontario 4th of July festival was discussed and 6 staff members from the fire dept. will be needed for Saturday, which is 1 more person than normal. We do receive \$500 for coverage of the fireworks. Ohio Health &/or Avita may be available to staff the first aide tent and the Chief will look into this.

Also, the fairgrounds want to have fireworks during the fair and will be shooting them off on township property. Chief has discussed this with the fair board and discussed concerns about the wooded property where the fireworks would be shot off. He will continue keeping the Board up to date on this matter.

Chief Carey informed the Board that Lane Bachelder has submitted his resignation as a part-time firefighter effective May 28, 2021.

Motion #112-21: Trustee Orewiler made a motion to accept the resignation letter of May 28, 2021 from part-time firefighter Lane Bachelder effective June 1, 2021. Seconded by Trustee Rose and upon a roll call vote, all members voted "AYE."

Trustee Rose informed the Board that according to the Prosecutor's Office, we are unable to sell scrap that is township property and use the funds for the 4th of July festival.

Trustee Orewiler informed the Board that Prince Excavation on Rock Road is finally attempting to sell the property. This property has had many zoning issues in the past and is not zoned commercial.

The air conditioning unit at Station #2 broke and emergency repairs are being done at a cost to be determined.

Trustee Gleisinger updated the Board on the road department. They have been dealing with numerous burials and have been doing a lot of mowing. Met with another tree company for a quote but it has not yet been received and hopefully will have it at the next meeting.

Richland County Soil and Water did their annual inspection of the Road facility. The inspectors stated that our guys keep a neat and organized garage and facility compared to other townships that they inspect. JD mower 6320 blew a front tire and was replaced. They went ahead and got 2 tires so they had a spare.
