Motion #155-21: Trustee Orewiler made a motion to pay the bills, seconded by Trustee Gleisinger and upon a roll call vote all members voted "AYE."

Public was given a phone number to call in to have access and participate in the meeting remotely.

The Board approved the purchase of a replacement door for Station #2 from J&B Acoustical in the amount of \$2,097.

Chief Carey presented the Board with a list of items that need to be disposed. The Board approved to have the listed items to be disposed of.

Chief Carey presented a quote to the Board from Atlantic Emergency Solutions in the amount of approximately \$6,000 for 10-firehose nozzles.

Motion #156-21: Trustee Orewiler made a motion to pay Atlantic Emergency Solutions \$6,000 to buy 10-new firehose nozzles, seconded by Trustee Gleisinger, and upon a roll call vote all members voted "AYE."

The Board discussed possible part-time hires. Eight individuals have been interviewed.

Motion #157-21: Trustee Gleisinger made a motion to approve the hiring of Allison Marstiller, Andrew Robinson, Nathan Volz, Brandon Cramer, and Jonathan Gifford, as at will part-time firefighters with a one-year probationary period effective August 9, 2021, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE."

The American Recovery Fund was discussed. It is similar to the Covid funds with some different documentation and restrictions. Possible purchases could be a new ambulance or turn-out gear.

The Richland County Fair will be having fireworks on Tuesday night. They will be set off on the township's side of Home Road.

The police car that was originally bought for \$1 as stated in prior minutes was actually donated by the City of Ontario instead of purchasing it.

Trustee Gleisinger updated the Board on the Road Department. They put in 3-catch basin and tile to fix the water issues at Springmill Cemetery. They are finishing up road mowing and helped Sandusky Township with ditching and spraying.

Trustee Gleisinger discussed an opioid settlement with the state. At this time, the township does not need to do anything regarding the settlement since we are a smaller township.

FO Kochheiser needed to know who will be attending the RCTA Picnic at Walton Lake as well as spouses.

Motion #158-21: Trustee Gleisinger made a motion to pass the Springfield Township Cyber Security Policy, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE."

The Board signed the July Management reports.

The Board received a letter of resignation from part-time firefighter Joe Smith.

Motion #161-21: Trustee Gleisinger made a motion to accept Joe Smith's resignation effective August 9, 2021, seconded by Trustee Orewiler and upon a roll call vote all members voted "AYE."

Motion #162-21: There being no further business to come before the Board, Trustee Orewiler made a motion to adjourn, seconded by Trustee Gleisinger, motion carried.
