Trustee Daugherty does not have an update from Clemons and will bring that back to the next meeting. He was ill and unable to respond to them regarding some questions they had about the survey that they will be sending out.

The MagneGrip installation has been completed at St 1 and Trustee Daugherty has reviewed the system with Lt. Meredith and others. He will be working with the installers tomorrow at St 2 and they should be finished at the end of the week.

Trustee Gleisinger updated the Board on the Road Dept. Dexter has provided us an insurance certificate to cover the transportation of our new JD tractor & mower that is being taken to the OTA Trade Show. Dexter has also offered us savings on parts for letting them demo the tractor. We accepted the 20% off of parts, which was listed as Option #1.

F.O. Kochheiser presented the Board with a waiver of health insurance for 2023 from Anthony Shelton.

Our retention is at its worse and we are looking at losing 4 employees currently.
