Motion #167-2023: Trustee Gleisinger moved to purchase 6 new tires for the 2015 F-550 Tool Truck at Wilson's for \$2,185.92, seconded by Trustee Carns, and upon a roll call vote all members voted "AYE."

FO Kochheiser presented the September Management reports for the Board approval, and the same was approved and signed.

FO Kochheiser also informed the Board that she found someone she would like to hire for a FO Assistant. Her name is Amanda Hike, and she was referred to her by the director at the Board of Elections, where Amanda is currently volunteering. She presented the Board with her resume and told them she will be hiring Amanda Hike as the FO Assistant effective today at the rate of \$15.00/hr., with an anticipated increase at the beginning of 2024 based on performance. She has adequate funding in the line item in which to pay her salary and has the authority to do so pursuant to ORC Section 507.021. According to ORC Section 507.03, she will also be ordering a bond for her in the amount specified in the code.

I/C Spellman updated the Board on the Fire Dept. with run and personnel reports for September. He also presented a proposed policy for part-time employees. This has been sent to Brian Butcher at Clemons & Nelson. He also requested an executive session to deal with some inactive part-time employees.

The fire truck at Brinley is still not sold. It is listed at \$350,000. He is requesting a more serious conversation to replace our current truck as we are having issues again with L-23. The safety features on this truck are also unsafe, as the bucket will not level. Brinley did mention they can take the truck in on trade. He informed them of other truck maintenance that has been taken care of.

Public Comment:

Craig Hunt asked about Schram Industries and the invoice for \$10K. This was a repair on the Road Dept. Turbo. They do a lot of work for both the fire and the road departments.

Michael Casto – Lexington-Springmill Rd. - he asked if the legal counsel reviewed the Verizon contract and who is the township's legal counsel, and he expressed his opposition in having the tower placed in a residential area.

Trustee Gleisinger informed all the residents of the zoning process as well as the duties of our Zoning Inspector.

Gino Mollica asked if the Trustees made any consideration as to the tower being placed in a residential area. This contract was first signed 4 years ago, and Trustee Gleisinger did sign the contract.

Craig Hunt also stated that the tower would be a health risk to the firefighters as well, having to work underneath this tower. We should take them into consideration as well as the residents.

Mike Wilson asked if we would be discussing the Wage and Benefits package tonight, and Trustee Daugherty stated they would be discussing it in Executive session. He asked if they would have the opportunity to give their input on the document? He stated that the Board originally stated they would have several meetings with the employees and that hasn't happened.

Motion #168-2023: Trustee Carns made a motion to go into executive session at 7:28pm to discuss the appointment, employment, dismissal, discipline, promotion, demotion or compensation of an employee or official, or the investigation of charges or complaints against an employee, official, licensee or student, unless the employee, official, licensee or student requests a public hearing, seconded Trustee Gleisinger, motion carried.
