The Cadet program was discussed, as we used to have this program years ago under Chief Henry, and the FD would like to bring it back to help recruit new younger employees. We would sponsor the Cadet and he/she would be able to pick up shifts while taking classes. They could be hired at minimum/lower wage until they pass classes. Details can be discussed later but they would like to get started. I/C Spellman will put together the information for the Board. They are all in agreement that they would like them to move forward with the project.

Cpt. Mullins is representing Junior Achievement on behalf of Springfield Township tomorrow to help recruit high school students to become firefighters.

Trustee Gleisinger stated there was nothing new with the Road Dept. There is a driveway next to the Cemetery on Millsboro and Trustee Daugherty asked if they would be putting a cable across it. He will follow through with the Road Dept on this.

Trustee Gleisinger presented a revenue & expenditure projection for the Fire Department, with a 4% & 5% increase to see when new money would be needed to keep the department running. The current funding at those percentage increases would last until 2030.

He also put together a Vehicle replacement schedule for all the Fire Dept vehicles and stated an additional 1M levy would be needed for Equipment to fund this schedule. He also included the levy schedule. He recommends renewing the 2 levy's that are up for renewal next year.

FO Kochheiser presented the Board with a copy of the proposed 2023 Permanent Appropriations but Trustee Daugherty did not have a chance to review them due to his internet issues. The Board agreed to bring these back at the next meeting for approval.

FO Kochheiser also updated the Board of the Net2 Services check that was voided by Trustee Gleisinger and Trustee Carns from the last meeting due to the unauthorized charge of \$230 for the camera installation in the township hall. FO Kochheiser prepared a warrant for the regular charges for the invoice, the IT maintenance and station phones, however, since no one followed up on the \$230 charge for the camera, she has requested an opinion from the Prosecutor as to how to proceed with that portion of the invoice.

## **Public Comment:**

Craig Hunt - Craig heard that Governor DeWine has passed some Bill regarding the State paying Marc's radio fees. The Bill is in the works but we don't think it has been passed yet.

Mike Wilson - Mike asked for an update on Clemons & Nelson. Trustee Carns stated they are meeting with them tonight in executive session after the meeting. He also stated that the Cadet Program is a good idea but our department just doesn't have many positions to move up in as he has been here 20 years.
