A/C Spellman is looking into the high water/sewer usage at St#1 as the bill has tripled in the last 2 months.

A/C Spellman asked about the P/T trainee job description that he gave the Board for their review, as he would like to get this approved. They would be paid the same as a current part-time FF. This position takes the place of the past Volunteer FF position that we used to have. Trustee Gleisinger thinks they should be paid less than what a regular part-timer makes and shouldn't be paid until they are certified. Trustee Carns agrees. They will look into the legality of workers comp issues if they are going on runs without pay. The Board approves sponsoring Caden Boebel and Tylor Danals so they can begin their schooling and will further discuss the job description and pay.

The ladder truck is listed, and we've had a couple of inquiries about it. At the last meeting, we discussed selling L-23 and getting a tanker, and he shared the information/bid he received from them at \$814,000 with possible deductions totaling \$57,500. There will be a \$150,000 price increase coming at the end of June from Cummins on the engine, so he would like to move quickly on this. Even if ordered in June, it will take 2 1/2 years to get. We need to check on whether or not this pricing is on a state contract or if we would need to bid this out. The Board agrees we are not in a position to move on this by the end of June, as more time will be needed to look into other bids and prices, etc.

One of Station 2's HVAC units had some serious repairs last summer and has frozen up again. This is the one that cools the rear area of the building. A/C Spellman feels a new unit is warranted. Trustee Gleisinger suggests he gets a couple of prices on a new unit.

A/C Spellman also presented 96 hours of sick leave donation from Dennis Gast to another fire department employee for the Board's approval.

Motion #87-2023 – Trustee Carns moved to approve the donation of 96 hours of sick leave from Dennis Gast to an employee in need, seconded by Trustee Gleisinger, motion carried.

Trustee Gleisinger updated the Board on the Road Department as they are currently mowing roadsides and cemeteries.

He also presented proposals for Chip & Seal. The first one from Small's is for asphalt with single chip & seal for Alta West Rd. (from Marion Avenue to Lexington-Springmill) with Option 1 (a 1.25" overlay) at \$103,433.96 and Option #2 (a 1.50" overlay) at \$118,209.46. The second one is for the chip and seal of multiple roads in the amount of \$95,887.95. We also have committed around \$75K for the joint contract with Madison Township. Trustee Gleisinger suggests going with the second one to keep within our annual amount of around \$160K. Next year they will do Alta West and Wiles Estate. Trustee Carns would like to hold on to this until the next meeting when Trustee Daugherty is present.

Trustee Gleisinger asked if the Cobra policy has been re-written for our Township, and Trustee Carns said she has not done that yet.

He also asked about the cell tower contracts with Vertical Bridge and with Verizon. Trustee Carns will check on the Road Dept. Tower contract with Vertical Bridge.

FO Kochheiser presented the Board with the May Management reports for their approval and signatures. The same was signed and approved.

FO Kochheiser updated the Board on the 2021/2022 Audit that is currently being conducted by CPA Ken Phillips of Wilson, Phillips, Agin, CPA's, Inc. They were at the township hall with her this past Tuesday, June 6th for the entire day, and she pulled numerous boxes of records that they needed. She presented each of the Board members with a "Related Party Questionnaire," which was signed by each member and returned to her. Two original "Letters of Understanding" were also presented and signed by two of the board members. These must be scanned and emailed to the Auditing firm asap.

FO Kochheiser is currently working on the 2024 Tax Budget that will need to be approved at the next meeting. She and A/C Spellman are meeting this week as well.

Trustee Gleisinger will look into a possible line of credit for future equipment purchases.
