Motion #84-2025: Trustee Orewiler moved to accept the new Job Description for Administrative Assistant, seconded by Trustee Gleisinger, and upon a roll call vote all members voted "Aye".

Motion #85-2025: Trustee Orewiler moved to accept the new Job Description for Part-time Firefighter, seconded by Trustee Daugherty, and upon a roll call vote all members voted "Aye".

Motion #86-2025: Trustee Orewiler moved to accept the new Job Description for Full-time Firefighter, seconded by Trustee Daugherty, and upon a roll call vote all members voted "Aye".

Trustee Gleisinger updated the Board on Road Department. They have been mowing cemeteries and repairing sinking graves. They also repaired a tile on Bowers Road as well as some catch basin repair.

The construction by ODOT is complete on St Rt 314. There was damage by the semis on Flowers and Pinkney Road. Trustee Gleisinger & Road Superintendent Kleilein met with ODOT, and they will take care of all repairs and were very receptive. This should be completed within a couple of weeks.

Trustee Gleisinger was contacted by Sandusky Township, and they would like to meet to discuss the upcoming renewal of the Fire Service Contract between us and them. He and Chief Spellman will meet with them in the near future and will bring proposal back to the Board for approval.

Trustee Gleisinger presented the Board with the necessary documents to proceed with the Road Resurfacing Bid for 2025 with advertisement dates of 6/5/25 & 6/12/25 with bid openings to be held on 6/23/25. This includes Snodgrass (314 to Rock Rd) & Alta West (Sheirer to Lex-Ontario) with 1 ½" overlay for an estimated total of \$265,000. Bid specs will be available on our website.

Motion #87-2025: Trustee Gleisinger moved to go out for bids for 2025 Road Resurfacing per the bid specs for Snodgrass Road (314 to Rock Rd) & Alta West (Sheirer to Lex-Ontario) with 1 ½" overlay, with advertisement dates of 6/5/25 & 6/12/25 and bid openings to be held on 6/23/25, seconded by Trustee Daugherty and upon a roll call vote all members voted "Aye".

Chief Spellman forgot to include the need to rescind **Motion #45-2025** regarding the hiring of PT FF Tyler Lee Jones, as he quit before working a shift.
