Chief Spellman recommended FF/EMT Tanner Keinath and Gabe Ivy, to the Board for part-time positions.

Motion #114-2025: Trustee Daugherty made a motion to hire Tanner Keinath for a part-time FF/EMT position pending he passes his physical agility test effective August 9, 2025, with a one-year probationary period, seconded by Trustee Orewiler, motion carried.

Motion #115-2025: Trustee Gleisinger made a motion to hire Gabe Ivy for a part-time FF/EMT position pending he passes his agility test effective August 9, 2025, with a one-year probationary period, seconded by Trustee Orewiler, motion carried.

Chief Spellman presented a quarterly report to the Board from the Springfield Township Fire Prevention Bureau containing a breakdown of services the Bureau provided.

Trustee Orewiler attended the safety council meeting last Thursday and within 10 months Springfield Township should receive a discount on BWC for attending the meetings.

Trustee Orewiler updated the Board about Rocky's property on Lewis Road. The property is not perfect, but the yard looks the best it has in 12 years. His boys spent a couple of days whacking weeds and Trustee Orewiler mowed once more with his bush hog so a professional landscaper could come in and mow. Since then, a professional landscaper has mowed, and Tate Moyer paid the bill. Excess vehicles are still on the property.

Tate Moyer was asked by the Health Department to take a test of the discharge coming from his sewer at his expense. Tate agreed to get the discharge tested. The original plans to fix the flow of the discharge will not work and the flow will still have to go to the ditch. The Weisman's on the corner of Lewis Road were concerned about Tate's discharge coming down the ditch and sitting there. In front of Weisman's property there is a culvert and basin, and Trustee Orewiler went searching for tile and the piping does not lead to anything. Trustee Orewiler discovered the culvert must have been plugged and the Road Department will look at it and clean the culvert out at the beginning of the culvert. They are not going to disturb anything except for the beginning of the culvert. Ms. Weisman is upset because she was told she would have to pay for the drainage. There was an accident a while ago that caused issues where the water was not draining. She is getting flies and mosquitoes from the stagnant water sitting in the ditch. Trustee Orewiler reassured Ms. Weisman the culvert will be cleaned out this week and this will take care of the standing water problem. Once the culvert is cleaned the water will drain down ditch into the 12inch pipe at the culvert. Tammy Weisman also was upset with the way her property looked after the edge of her property was cleaned up by the County. Her hill on the side of her property was already steep and now it is steeper, and she is unable to mow that portion of her property.

Trustee Gleisinger received a complaint from the road department about issues with ATVs running in the back of the Road Department Building and tearing things up. It appears they are coming in from where the Halloween events are held. There are tracks on this property as well. AC Shelton suggested possibly a deer cam would help to catch the offenders. Trustee Gleisinger thought a deer cam would be good if the damage continued. The Road Department also installed a new drive pipe on Brookdale for a resident as well

as a drive pipe on Rudy Road. Trustee Gleisinger informed the Board the batteries for the new loader were no good and they are going to be replaced.

The City of Ontario would like to sell a Ridgid CS6 Seesnake Monitor with batteries and charger as well as a Ridgid CS6 200-foot camera reel with misc. accessories for \$5,000.00.

Motion #116-2025: Trustee Gleisinger made a motion to purchase Ridgid CS6 Seesnake Monitor with batteries and charger and Ridgid CS6 200-foot camera reel from the City of Ontario for \$5,000.00, seconded by Trustee Orewiler and upon a roll call vote all voted "Aye".

Trustee Orewiler talked to Kim Currens about putting something other than pea gravel at the end of her driveway because gravel is falling into the ditch and clogging. Trustee Gleisinger added the tile is not draining because it was full of pea gravel. Trustee Orewiler asked if the Township could send out a letter to suggest she replace the pea gravel with larger gravel pieces. Trustee Gleisinger will talk with the Road Department about the situation, and he can call Kim Currens. Trustee Gleisinger also asked Tammy Weisman to leave her number so that he could contact her.
