Last Wednesday Chief Spellman received notification that Noah Sgambellone is resigning his full-time position to continue his schooling and would like to keep working part-time effective September 1st. His first part-time shift would start September 6th. The Township would need to replace his position with another employee in the Safer Grant.

Motion #120-2025: Trustee Gleisinger made a motion to accept the full-time resignation of Noah Sgambellone effective September 1, 2025 and to immediately start his part-time position September 1, 2025 with his first shift on September 6, 2025, seconded by Trustee Orewiler, motion carried.

Since the Fire Department would need to replace Noah in the Safer Grant, Chief Spellman referred to the list of interviewees conducted awhile ago. He discussed possible replacements with AC Shelton, and they would like to recommend Jonathan Smith. Joanathan is almost finished with paramedic school and has been employed with Springfield Township for a little over a year. He will be put in the Safer Grant effective September 6th.

will be paid with Safer Grant Funds effective September 6th provided he passes his agility test with a one-year probationary period, seconded by Trustee

Chief Spellman would like permission from the Board to allow AC Shelton to sign acquisitions in Chief Spellman's absence. Board approved.

FF Brandt's service laptop is bogging down, and he has requested a new one with a dock. Grand total would be \$1,154.32 on Amazon. Board Approved.

The mosquito traps set in Springfield Township tested positive for the West Nile Virus. There was a nice article in the Tribune about what residents can do to help protect themselves from the virus.

Trustee Gleisinger updated the Board on the Road Department. There was a complaint by resident on Murfield Drive about someone parking an RV on an abandoned lot. The Road Department helped Sandusky Township with a cross pipe, mowed Cemetery, and on July 31st started mowing roads. They are getting roads ready for paving and called Kokosing to schedule. There is also a water issue on Noblet Road.

Rocky's Yard has become a common discussion at meetings. The yard was moved and looked nice. His sons are paying for local landscapers, however there is still an issue with cars on the lot.

Trustee Orewiler discussed the sewer discharge situation on Lewis Road. The Road Department found the catch basin and now hopefully the Township can locate a culvert, if there is one, going south from the catch basin. If one can be located, then the Township will be able to hook up resident's sewer to the catch basin.

Trustee Orewiler discussed the generator at Station 2. He commented that Chief Spellman and AC Shelton didn't need to comment on the generator right now because he is not in a hurry to pay the money but probably should get things going in that direction. Chief Spellman would like to upgrade to a new unit that is more reliable and will run the whole station. The Fire Department is a Safe Haven so it would be a really good idea to get one that can accommodate everything that needs power at the station. The Township will have to bid the generator out and get it on the fore front again. Trustee Gleisinger asked in what year was station #1's generator installed? Those specs would guide the specs for Station #2 and Trustee Gleisinger will get the Specs together once he gets the old specs. FO Kochheiser will send the bid specs to the prosecutor once Trustee Gleisinger gets them together and the prosecutor will let the Township know if anything is missing. Station #1 was not bid out so there would be no bid specs for that project. The project came in \$25,000 under the requirement to bid. FO Kochheiser will find bid specs to use as a format for Trustee Gleisinger. Trustee Gleisinger will ask Gracie for help to get the bid together and put out on the website.

Trustee Orewiler wanted to bring up the Culvert for Station #1. Chief Spellman mentioned the situation a couple meetings ago and about putting in a French Drain. There is standing water in the yard, and the Township needs to get something done. Trustee Orewiler suggested to start at the road and find tile that goes into the retention pond and then backfill which will create a French drain on top basically. With this suggestion the whole yard would not have to be dug up.

Trustee Orewiler addressed AC Shelton and Fire Chief Spellman about not informing the Board of their new employee Tilly, a Dalmatian that was adopted by the Fire Department from the Richland County Dog Pound. Trustee

Orewiler believes that this will create great public relations with having a dog at the firehouse and the fact that she was a rescue dog. The department thought it would be good idea for therapy helping the Firemen with PTSD. The department checked to make sure no employees had any allergies and all the supplies for the dog are being funded by the employees who are responsible for the dog. The dog goes in a crate when the Firemen are not present, and employees know that if she starts lashing out then Tilly will have to go back to the dog pound. FO Kochheiser asked if the Township would need insurance in case the dog would bite someone. Chief Spellman stated he will ask Rhinehart about the insurance. The department has a muzzle in case there are situations that she becomes overwhelmed with.

FO Kochheiser stated that the July Management reports were completed and she had emailed them to the Trustees. If they had time to look them over and want to sign the reports tonight that would be great, however if they need a little more time it is okay. Trustees did sign and approve the reports.

<u>Public Comment:</u> Joyce Taylor has a neighbor that is putting in a fence and she believes the fence is being installed on her property. She asked the neighbor to have a survey done and the neighbor refused. She also asked her neighbor to go to the Auditor's Office to assess property lines, and he refused. She does not know what her options are to remedy the situation. She is going to call Steve Arnett, the Zoning Inspector. Trustee Gleisinger informed Joyce that Steve would be her best resource because he takes care of zoning and he will let her know what the rules are for installing a fence in Springfield Township. Joyce has a lawn mowing service that comes and mows her lawn and now they can't get through where the fence was installed. She is trying to find a civil solution but is not seeing it right now.
