1. Run volume & patterns: 578 runs 4th qtr 2018 (Total 2018 calls: 2,029)

Major incidents:

- a) Mutual aid w/ Crestline (Engine 23), structure fire, E. Main St., 10/21
- b) Two car accident, both cars w/ pin-in's, Lincoln Hwy. Squad assists from Madison & Crestline, 11/17
- c) Mutual aid w/ Madison (Tanker 21, Eng 22), structure fire (2 alarms), 693 Lenox Ave., 12/5
- d) Mutual aid w/ Crestline (Engine 23, Squad 21), structure fire, 1511 Stevens Rd., 12/15

5. Training:

- b) Dec. 1: Annual Saturday seminar by Chief Graylen Stargell on leadership and vision topics; many personnel from area dept's also attended.
- c) Outside/Other classes: Fire Officer II (FF's Brant, Metzger); Inspector Bradley to sprinkler/fire alarm & fire code seminars.
- d) Annual Fire Inspector C.E. seminar hosted by STFD on Oct. 30. Many personnel from regional dept's also attended.

6. Inspection Bureau:

- a) "Do Not Enter" (for firefighting) placards program for targeted hazardous abandoned structures initiated.
- b) Several private complexes had fire hydrant testing and inspections performed.


7. Other:

- c) New equipment: Two new thermal imagers and piercing nozzle for Eng 22 (from grants). Five new sets of turnout gear received.
- d) STFD Harassment Policy updated and adopted. Automatic mutual aid SOP adopted.


